MARKET REGULATIONS

Please keep a copy of these regulations for your records

- 1 Having a stall at the Show is conditional upon compliance with all Show Regulations
- 2 Stall allocation is at the discretion of the Ground Space Co-ordinator.
- 3 Stall holders must comply with all instructions given by the Ground Space Co-ordinator.
- 4 Requests for a particular site will be considered, however it can not be guaranteed.
- 5 A copy of your insurances, Certificate of Currency, must be provided with your application.
- 6 Payment must accompany applications. Invoice will be supplied on confirmation of application or payment refunded if not successful. No payment, no allocation.
- 7 Set up is available from 6:00am with staff onsite from this time. All vehicles must be off grounds by 9am.
- 8 It is the responsibility of Stall Holders to ensure the security of their stall, equipment and product.
- 9 Stall Holders will not insult or intimidate other Stall Holders, customers, or Committee. Such action will result in cancellation of stall allocation.
- 10 Customers shopping will be treated with courtesy and respect Fair Trading Practice consistent with Consumer Law.
- 11 Stall Holders selling food will need to arrange with the Shire of Boyup Brook the appropriate notification.
- 12 Any request to cancel an application by a Stall holder is requested in writing and must be provided a minimum of 7 days prior to the event.
- 13 No sale of the following items allowed, please remove from sale - cap guns, imitation guns, toys with firing capabilities, spray cans, etc. Please also remove any items that flash or have laser capabilities from sales.
- 14 'Friends of the Show \$10 Gift Voucher' Supplied by the committee can be used at any Dinninup Show stall and a refund will be honoured by the treasurer for stall holders when **submitted at the Show Office** on show day.
